

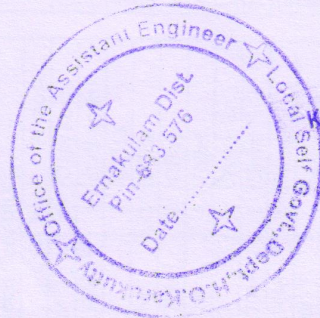


**NO OBJECTION CERTIFICATE**

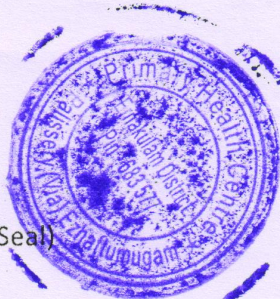

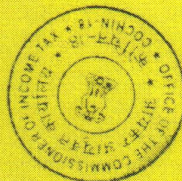


